Dear Parents,

This letter is to inform you that we will again be offering our 475hr Kindergarten Program for the 2010/2011 school year. Your child is eligible for Kindergarten if they turn 5 years of age by March 1, 2010.

Our program runs from 8:30 a.m. – 11:15 a.m., Monday through Friday from September to June. Unique to our Kindergarten Program is that we offer childcare both before and after the Kindergarten class for your convenience. We follow all curriculum guidelines set out by Alberta Learning and we use the Animated Literacy Program which is used by every other Kindergarten in Camrose. This will ensure an easy transition into grade one for your child.

If your child will attend our Kindergarten Program in the fall, we urge you to return the attached registration form along with a \$50 registration fee as soon as possible. Our maximum class size is 20 and we are giving all families who have children enrolled at the Centre the first opportunity to register. On February 1st we will be advertising and accepting registrations from the general public. Be sure to secure your spot early!

In addition to a non-refundable registration fee of \$50 we ask that you bring along your child's birth certificate and a copy of their Alberta Health Care.

If you should have any questions with regards to our Kindergarten Program, please feel free to ask. I would be more than happy to answer them for you.
